Wedding DVD Packages

Platinum DVD Memory Package - \$1495

This package includes from the hair and make up to the first dance. The filming starts with the bride getting ready and then the groom. (Where possible), guests arriving for the ceremony, the wedding service and footage of the photo's taken at different locations after the wedding service. Also includes the wedding speeches, the cutting of the cake and the first dance. I also put a montage of 30 to 40 wedding photos at the end of the wedding DVD with your favourite song. (This package includes 3 DVD copies)

Gold DVD Memory Package - \$1295

This package includes from when the guests start to arrive for the ceremony to the first dance. The filming starts from when the guests arrive for the ceremony, the wedding service and footage of the photo's taken at different locations after the wedding service. Also includes the wedding speeches, the cutting of the cake and the first dance (Includes one DVD copy)

Silver DVD Memory Package - \$995

This package includes from when the guests start to arrive for the ceremony to the start of the reception. The filming starts from when guests arriving, the wedding service and footage of the photo's taken at different locations after the wedding service up until the start of the reception. (Includes one DVD copy)

Ceremony Package - \$795

This package covers the main part of the day from when the guests arrive until the end of the ceremony. Also includes some footage after the ceremony at the venue.

In the event that more than one client wishes to book wedding services on the same day, preference will go to the first client to pay the deposit. Rescheduled weddings will only be accommodated if the new date does not conflict with another booked wedding.

Bride and Groom Films will be the exclusive professional Videographer. Friends and family are permitted to operate video cameras on the condition that they do not interfere with or get in the way of the professional coverage.

It is the client's responsibility to secure access to areas for videography. *Bride and Groom Films* will not be responsible for coverage lost due to access restrictions.

Creative aspects such as shooting and editing style are at the discretion of *Bride and Groom Films*.

Bride and Groom Films will not be held liable for any production problems beyond our control, e.g. bad weather, accidents, poor acoustics/lighting, interference from guests, etc.

Bride and Groom Films reserves the right to terminate this contract at any time for any reasonable cause, e.g. accident or ill health. In this event all monies paid will be refunded in full.

Any liability on the part of *Bride and Groom Films* will be limited to the amount of monies paid.

Upon taking possession of the finished product, the client must inform *Bride and Groom Films* of any technical or other problems with the video within 7 days. After 7 days, if no notification has been received, the client will be deemed to be satisfied with the product.
